## Arrow District - Chandlers Ford Scout Campsite at Cranbury Park

## Campsite Rules

- 1. All Camps and Nights Away experience or events must be run in accordance with the Policy, Organisation and Rules of the Scout or Guide Association.
- 2. The site is within the private Cranbury Park Estate. The lakes, woodland and fields around the site are out of bounds to all site users with the exception of the public footpath which passes the northern side of the site.
- 3. Entrance to the site is from a private gateway from Hocombe Road opposite the junction with Kingsway. This also serves the private estate and must be kept closed at all times.
- 4. All vehicles must be parked in the car park area along the site entrance road.
- 5. All gates, access areas, and paths to the site must be kept clear at all times for site and emergency vehicles use.
- 6. Vehicles are not permitted on the campsite. You may push your trailer to and from your site.
- 7. Hand trolleys are provided to transport your equipment to and from your site. They should be returned to the area next to the entrance as soon as loading/unloading has been completed.
- 8. No caravans or camper vans are allowed on the estate or on site.
- 9. Please respect the curfew and ensure all your group are quiet between 2300 and 0700. If generators are used, they must not be operated during the curfew.
- 10. No fire is to be lit on the ground, except in the campfire circle.
- 11. Cooking may be done with gas stoves or by using the altar fires in the designated area.
- 12. Fallen wood may be collected from the ground around the site but it is strictly forbidden to take wood from live trees for any use. Chain saws are not permitted.
- 13. Any used or partially used wood should be returned to the woodpile. Spent wood ash to be deposited in the ash pit near the wood pile.
- 14. The use of axes and knives is only permitted in the wood-chopping area adjacent to the altar fires. Handsaws may be used adjacent to the wood pile.
- 15. No flame, fire or cooking is allowed in the Round House. It is a wooden structure and is intended to be used as a shelter and meeting place only.
- 16. No turfing, pits or fire holes to be dug. Consequently, only above ground wet pits may be used.

- 17. Washing-up may be carried out in the camping areas, but the water must be disposed of at the washing-up stand in the Altar Fire area. Water points and the toilet block hand basins are not to be used for washing-up. Please remember that the water is metered.
- 18. The toilets drain into a septic tank and therefore nothing other than normal toilet waste or toilet tissue is to be flushed away.
- 19. Under normal circumstances the use of trailing leads for supply of electricity to sites is not permitted. If trailing leads are required for a special purpose, then permission must be sought prior to the event.
- 20. Any electrical appliances brought to be used on site must be PAT tested prior to use.
- 21. No animals, including pets, or birds of prey, are allowed on the site. Assistance Dogs are permitted.
- 22. No shooting or pyrotechnics are allowed.
- 23. Any adventurous activity must be supervised by an authorised person.
- 24. It is the responsibility of all campers to ensure the buildings and facilities are kept clean and tidy. If there is more than one group using the site then agreement should be reached between the groups as to the cleaning programme. Cleaning materials are available.
- 25. Please ensure that when you leave the site, it is left as you would expect to have found it on arrival.
- 26. All rubbish must be removed from the site when you leave.
